- Hole by drain in parking lot will need more repair. Brian will take care of it.

#### **New Business:**

- 1. **Ordinance** to Completely Prohibit the Establishment or Operation of Recreational Marijuana Establishments in the Township was presented for approval. Roll call vote: Willison yes; Jackson yes; Ludema yes; Thompson yes. Absent Larry Patrick. Ordinance was adopted and will be published in local newspaper. Ordinance will take effect 30 days after publication.
- 2. Blight Ordinance and Civil Infractions Ordinance need more clarification before next meeting.
- 3. **Letter** from Veterans Village USA about fundraising in township sent to village since the group would probably be working within the village limits.

#### **Old Business:**

1. **Website** is ready to be launched. Campbell Township minutes of meeting will be published on the website along with financial reports. We will no longer publish minutes in local newspaper but will put a notice in the Lakewood News that they are available on the website. Also will request that a link to county for various permits and forms be added to the website.
