

# Campbell Township

## Regular Meeting

August 11, 2022

Present: Dan Jackson, Dennis Pepper, Linda Willison, Marshann Ludema. Absent: Brian Thompson

Six visitors attended.

Meeting was called to order at 7 pm by Clerk Marshann Ludema. Pledge to flag was given. Clerk appointed Dan Jackson to run meeting in Supervisor Brian Thompson's absence.

Minutes of last meeting were approved with change to 'Review of Policies' line to read: "...within the next couple of years." (Linda, Dan)

**Public Comment:** A resident asked about Boston Township taking more of a responsibility for upkeep of Goodemote Road since there are more Boston Township residents who live along that road than there are Campbell Township residents.

**Fire Department:** Paul reported that the radio grants they are applying for have been pushed out for a couple more weeks.

**Road Contract** – Supervisor received confirmation that Boston Township has approved paying a share of the Goodemote Road project which would apply limestone on a portion of Elm Road and all of Goodemote Road between Jackson and Elm Roads along with necessary preparation work. Township share will be \$59,430.56; Boston Twp share will be \$30,538.25.

**Political Signage Policy.** Clerk presented board with a written policy regarding placing of political signs on any of township properties. Motion to approve policy by Marshann, supported by Dennis. Motion carried.

**Township Hall air conditioner** – An estimate from Welton's for replacing faulty air conditioner at township hall from Weltons - \$5,170.00. Estimate to replace both air conditioner and 19 year old furnace is \$8,360.00. Motion by Dennis, support by Dan to accept bid for both air conditioner and furnace. Carried.

**Township Assessor** – Brian has spoken with Brian Buscher, who is interested in taking the Assessor position. Board members have been provided with a copy of his contract and Brian Buscher will plan to attend our September meeting.

**Auditor** – Brian has spoken with a firm who is interested in taking on Campbell Township auditing duties and they will provide a quote.

**Wind and Solar** – Information packets have been given to all board members to look over. Discussed the need to have something in place in Campbell Township before companies come with interest in our township.

**Township Hall parking lot** – Discussed adding a 200 x 100' section to existing parking lot which would add about 45 spaces for parking.

**Township Park Handicap Parking** – Dennis presented drawings for 3 handicap spaces to be added to the east of the concession/restroom building. Some trees would be removed to open up enough room for these additions.

**Bills** totaling \$13,186.15 were approved for payment. (Dennis, Dan)

**Financial Report** was approved as presented. (Dan, Dennis)
